

Meeting Minutes: 3/7/2020

- Called to Order: 10:00 a.m.
- <u>Previous February meeting minutes reviewed</u>: Jim moved, Armas second. February minutes were approved.
- Treasurers report:
 - Reviewed the deposit from Amazon Smile of \$42.41
 - Reconcile books report
 - Reconciles to balance sheet
 - Review of forecasted expenditures
 - Donations are up
 - Membership 17% increase
 - \$10,213 this year; \$8,700 last year
 - Donations 21% increase
 - \$46,000 this year; \$10,000 last year
 - Total increase in revenue is 38% from 24,000 to 63,000
 - o Motion was made and accepted for the Treasurer's report.
- Project Status:
 - Dale will meet with Nate the week of 3/9 to review projects
 - o Dale requested a list of volunteer for the erosion sites
 - o Facebook page is active, Dale is working on it daily
- Watershed Management Plan
 - Armas reported on Greg Goudy review of the watershed management plan. The final report is expected to be (including edits) by the end of March. Once it is resubmitted it should be approx. 4-6 weeks for approval. Some suggestions for edits were:
 - Need more river flow rate data
 - Need more detail regarding water quality
 - Edit formatting
 - Watershed Management meeting was 3/6. Approx. 16 people attended the meeting.
 There was good feedback from the group. Tasks lists were identified.
 - o Armas is working on getting monitoring stations active and implemented.

Grants:

- We are awaiting reply on DNG FGHP for section II and CRA submitting for funds as well.
 - If this is approved, it will fund the Camstra project
 - Preapproval for \$170,000 was approved.

Old Business:

- Natural Rivers
 - Dan spoke with Brian Burry and would like to move forward with a letter requesting DNR designation from the board of trustees. He recommended that the letter should be addressed to the fisheries, and DNR manager.
 - Tim sent an email to Brian on 2/6 stating that the board is in support of a designation by a vote of 5 to 2.
 - A new discussion was had regarding the designation and the writing a letter to Brian.
 - Motion was made that the LMCC requests state designation of natural rivers designation. 8 approved; 0 opposed; 1 abstained
 - Dan will move forward with writing the letter
- o Website Updates
 - Dan will review with Steve and Anna following the meeting
- Real Estate Info Package
 - This is a work in progress
 - Mike Fisher will pass out to encourage landowners to have proper septic care.
- New Erosion Survey
 - CRA has agreed to do in spring 2020, costs the same as last one \$8402. LMWCC has approved funds
- 2020 Watershed volunteer meeting
 - April 17th, 2020 9:30, Mark Tenello is speaking
 - Snacks and food are provided by LMCC
- Newsletter

 - Chas is working on an electronic newsletter in addition to the printed newsletter.
