Project Management

Water Quality and Macro Studies

 - Found 3 occurrence of the 5 priority invasives
 - japanese knotweed (2), phragmites (1)
 - It was suggested that communication be created to go to members that would educate the community about invasive species, as well as adding communication to the website.
